

## Notice Of Development Variance Permit Application


Notice is given that Sidney Council will be considering the approval of Development Variance Permit Application No. DV100368 for 9895 Seventh Street and 9899 Seventh Street (*properties shown below*) at a Council meeting held in the Sidney Town Hall Council Chambers, 2440 Sidney Avenue, Sidney, BC, V8L 1Y7, on Monday, February 24, 2025, at 6:00 p.m. The proposed Development Variance Permit would vary the following sections of Town of Sidney bylaws:

The purpose of this Development Variance Permit is to relax the maximum distance exterior cladding is permitted to project into a required setback, the maximum percentage of a first storey occupied by parking area, and the location of required 3-bedroom units in order to allow a four-storey residential development.
